1. Executive Summary

Overstone Park Primary School (OPPS) is a proposed mainstream primary school set to open in the Overstone Leys development to the East of the A43 bypass between Moulton and Overstone Village. Northampton Free School Trust (NFST) undertook a 6-week consultation to confirm the public supports this opening in accordance with statutory requirements, which was open from Tuesday 11th of June 2024 to Tuesday 23rd of July 2024.

The purpose of this consultation is to fulfil NFST's statutory duty to inform the community of the plans for the proposed 4-11 primary school, and to consult with stakeholders and the local community on their views, in particular about whether Northampton Free School Trust should enter into a funding agreement with the Secretary of State for Education – thereby allowing the primary school to become a reality.

The number of individual responses received from the consultation survey was 82 responses, which were delivered online through a survey.

93.5% of respondents supported the proposal to establish the school, with significant positive feedback and comments from respondents across the board.

The findings from this consultation will be reported and presented to those that have responded, the local community and the department.



2. Introduction

Overstone Park Primary School is a proposed 4-11 primary academy which plans to open in Overstone Leys in West Northamptonshire County Council in September 2025.

The Overstone Leys development, specifically the east of the A43 bypass between Moulton and Overstone Village, was chosen as the site for Overstone Park Primary School due to the demand for new school places created by the new Overstone Leys development, and due to its capacity to support innovative, eco-friendly infrastructure. The development provides the necessary area for both indoor and outdoor facilities, ensuring a well-rounded environment for learning and playing. The Overstone Leys development, a sustainable urban extension to the north of Northampton, will provide up to 2,500 new homes. Overstone Park Primary School will largely provide for the children of young families forecasted to move into these homes over the coming years and for existing local families seeking a primary place for their children.

Overstone Park Primary School is being proposed by Northampton Free School Trust, incorporated in 2013. The trust is a single-academy trust in the process of forming a multi-academy trust (MAT) to manage its expanding family of schools. With a vision to create outstanding schools in Northampton, the trust emphasises strong academic achievement, the development of core values, and the promotion of citizenship, community, and service. Their first school, Wootton Park School, an all-through institution, opened in September 2016 and received an 'Outstanding' rating from Ofsted in 2019. Overstone Park Primary School will be the trust's second free school, following the successful model established by Wootton Park. The trust aims to foster confident, happy and successful learners.

In its opening year, Overstone Park Primary School will provide two forms of entry for children aged 4-11, gradually expanding with each new Reception intake until reaching its full capacity of 420 pupils. This state-of-the-art, co-educational, state-funded, non-selective school will be free to attend and will benefit from the leadership and curriculum support of Wootton Park School.



3. Background

Free schools and academies approved to open by the Department for Education must conduct a thorough and transparent statutory consultation with parents and local stakeholders before a final funding agreement can be put in place.

This is known as a Section 10 Consultation in reference to Section 10 of the Academies Act 2010. The Act states that trusts should consult such persons as they deem appropriate. The key question on which academy trusts are required to consult is whether the trust should enter a Funding Agreement with the Secretary of State for Education to open their new school.

Northampton Free School Trust devised and implemented a consultation exercise, supported by Premier Advisory Group, which sought the views of parents, stakeholders and the wider community on whether they should enter into a funding agreement with the Secretary of State for Education and open Overstone Park Primary School.



4. Vision and Ethos

4.1 Vision

At Northampton Free School Trust (NFST), our vision is to create an outstanding school, delivering strong academic achievement, developing strong values, and encourage citizenship, community, and service, raising standards in the local area. Our curriculum will aim to enhance social mobility and improve life opportunities for all learners, especially the most disadvantaged.

Overstone Park Primary School (OPPS) will passionately invest in positive outcomes, understanding that the impact we make on our young people's lives is crucial.

Our school will be the school of choice for parents who are ambitious, value academic success, and want their children to reach their full potential. Our children will be thoughtful, lawful, disciplined, community-focused, respectful, and accepting of diversity.

The school will adhere to the following key principles:

- Whole-school ethos of attainment for all: Never assume that all disadvantaged children face the same barriers or have less potential to succeed.
- Clear systems for addressing behavior and attendance: Believe that students must be
 present and attentive to access learning. This will be achieved through effective attendance
 and behavior strategies, clear communication of rules, and comprehensive staff training in
 behavior management.
- High quality teaching for all: Prioritise 'quality teaching first' by setting high expectations, monitoring performance, tailoring teaching and support to meet learners' needs, and sharing best practices across the MAT, supported by Sutton Trust research.
- Meeting individual learning needs, including SEND and LAC: Treat each learner as an individual with unique challenges, talents, and interests, providing targeted support for underperforming children both during curriculum time and outside school hours.
- **Effective use of staffing**: Identify the strengths of each staff member during recruitment and utilise them effectively, sharing expertise across the Trust.
- Data-driven and responsive to evidence: Utilise data to identify and address children's learning needs at every opportunity.
- Clear, responsive leadership: Drawing from experiences at WPS, staff will be committed to doing whatever it takes to help each child succeed.
- Well-being & work-life balance: Invest in the professional and personal development and well-being of our staff, providing regular coaching, access to external support, and regular performance reviews.
- Engagement: Engagement to build excellent contacts, foster strong relationships, and maintain a community focus throughout the school's journey, recognising the importance of community voice.



• **Community**: OPPS will be an integral part of the local community by forming mutually beneficial relationships with voluntary groups and local businesses.

4.2 Ethos

NFST is committed to viewing each child as an individual, avoiding stereotypes, and enhancing the life opportunities of every pupil in our care. We foster an inclusive ethos grounded in respect, tolerance, and understanding of others' needs to build self-esteem, cultivate positive relationships, and develop collaborative skills.

Our new school upholds a commitment to equal opportunities, which we strive to provide through Overstone Park Primary School. We will:

- Develop learners to help create a better society through the promotion of citizenship, community, and service.
- Create a rigorous, broad, and ambitious knowledge-rich academic curriculum supported by high-quality extracurricular provision.
- Grow a school at the heart of its community, helping to promote cohesion.
- Provide targeted support for every child that needs it, through high-quality classroom teaching and evidence-based targeted support, including tutoring.
- Ensure the highest aspirations and ambitions for all.

To support our disadvantaged learners, in line with NFER research, OPPS has based its core values and vision on seven key building blocks identified as essential in promoting high attainment among disadvantaged children (DfE Nov 15).



5. Consultation Methodology

5.1 Scope and Timing of the Consultation

The consultation was held between 12 noon Tuesday 11th June 2024 to 12 noon Tuesday 23rd July 2024. Before the beginning of the consultation, the Project Steering Group containing Trustees and staff (with delegated powers from the Trust Board) agreed on a consultation plan and stakeholder mapping exercise to ensure that the consultation was publicised to all relevant stakeholders.

5.2 Publicising the Consultation

As part of its general communications strategy for Overstone Park Primary School, Northampton Free School Trust (NFST) had already published a <u>website</u> available for public access. The website included details of the school's proposed vision and ethos, explanation of admission processes and policy, consultation questionnaire and FAQ.

A database of local stakeholders in Northampton was collated, and included:

- Primary and Secondary Schools
- Faith settings
- Health settings
- Leisure settings
- Community settings
- Daycare settings

Emails were distributed to all the stakeholders inviting them to learn more about the school and share their views. Information about the consultation events and a link to the <u>online consultation</u> <u>page</u> (which contains additional materials including a recording of a video presentation by NFST's CEO Dan Rosser) were included. (See Appendix 3.2 for the email sent to stakeholders.)

For the consultation, 2 drop-in consultation events were organised:

- 26th June 2024 Wednesday, 6.00-7.30pm, on Microsoft Teams online via Microsoft Edge or Google Chrome
- 15th July 2024 Monday, 6.00pm-7.30pm, at Wootton Park School, Wootton Hall Park,
 Northampton NN4 0HZ

In addition to the events, an online survey was set up using SurveyMonkey, which can be viewed in full in Appendix 1. This survey was composed of 9 questions about the proposed school, each with space for respondents to add comments and explain their views. It also invited respondents to add



their contact information and children's date of birth, so that they could be contacted in case they wanted to register their interest in the school. Details about the consultation meetings and online survey were added to the school's website. (See Appendix 5).

A consultation booklet was then developed for distribution. This consisted of an 8-page A5 document that includes information about the school, its proposed vision and ethos, curriculum aims, FAQs, a questionnaire and admissions criteria along with the school's website link and contact details.

The back page of the booklet was a detachable questionnaire where the five consultation questions could be answered. This section of the booklet could then be sealed and sent free by post to Overstone Primary Park School, c/o Wootton Park School, Wootton Hall Park, Northampton NN4 OHZ. Respondents could also scan it and sent it by email at

<u>info@overstoneparkprimaryschool.org.uk</u>. The booklet also included the URL of the online survey to encourage people to respond electronically.

1000 copies of the booklet were also distributed in the surrounding area of Overstone Park Primary School, as shown in the map below.



Following this distribution, mailing lists were created using the e-mail addresses supplied by interested families. These lists specifically targeted families with children aged 5 to 11 years old, who are eligible to start Reception during the school's first two years of operation. For further details on the email, refer to Appendix 3.1 and Appendix 3.2.



A copy of the consultation booklet was posted to each of these families, and the hard copies were used for the groups listed on the stakeholder Excel spreadsheet (except schools, which were notified via the council newsletter). Additionally, hard copies were left at the various housing developer offices for distribution, provided at the in-person event, and made available at Wootton Park reception.

Additional actions taken include publishing an advertisement in local media, communications from the trust and member schools, coverage in the Wootton Park School July newsletter, and Facebook posts shared by the trust and other local school pages. Press releases were also covered by the Northampton Chronicle & Echo and the Northamptonshire Telegraph, both online and in their local newspapers, with 26,000 copies sold (See Appendixes 6 and 7).




6. Results of the Consultation

The statutory consultation survey received a total of 82 responses. The survey enabled each respondent to provide both quantitative and qualitative analysis. Most stakeholders replied with a Yes/No answer, but a section of respondents added further comments on different aspects of the school such as the curriculum, the admission process, the positive support for the school opening, the opportunity offered and the school's unique value and ethos. The results covering each of the 9 questions are presented below.

6.1 Stakeholder group

Respondents were asked which stakeholder group they identified themselves as belonging to and had the ability to select as many categories as they wished. Respondents also had the opportunity to provide additional details on who they were in a free text box.




Most respondents (29) identified as Member of staff at a local school, followed by local resident (27).

6.2 Online Survey Questions

Q1. Do you support the Northampton Free School Trust's proposal to open a primary school within the Overstone Leys development area to the northeast of Northampton to meet the need for school places in the local area?



Out of the respondents, 77 answered this question and 5 skipped. 93.51% answered Yes, 3.9% answered No, and 2.6% answered Don't Know. Most comments on this question were positive feedback regarding the opening of a primary school in the Overstone Leys development area.



For those stakeholders who answered 'Yes' to Q1, the following comments were given:

- "Fantastic opportunity to have a high standard school in that area."
- "The area is a large developing housing estate and needs the infrastructure of schools, health, etc. in order to serve the needs of the residents."
- "Local Primary Schools are full, new houses are continually being built."
- With the growth of population on the new estate, a primary school within walking distance will be needed."
- "The NFS Trust has an excellent track record as exemplified by Wootton Park School"
- "There is a need for a new school in this area, given the new housing developments."
- "The Trust's other school is outstanding, and I would expect the new school to follow this trend."
- "I am a member of staff at WPS and have seen the high standards of education which is provided there needs to be more of this in Northamptonshire. I am also a local councillor and know that there is pressure on school places due to increased residential development. This new school will help ease that."
- "Need for primary places."



- "It will be great to have a primary school within one of the Overstone developments."
- "Each new area being built needs schools to support the growth of the area."
- "A local school within walking distance of a new development is important."
- "Clearly a need for a new school and will cater for a growing population in the area."
- "Positive for Northampton."
- "Increased population of young people requiring outstanding education."
- "There is a need for a school in the area and this trust has an excellent reputation. I would trust them to look after my children and gain the highest possible attainment."
- "Growth of Wootton Park; more school places; an outstanding provider."
- "Lots of new housing, shortage of school places."
- "It will mean a local school for the new housing development in Overstone Leys."
- "More school places required."
- "Need for school places in the area."
- "Requirement of school places and outstanding sister school to support the process."
- "With the new houses on Overstone Leys and the edge of Moulton, this will aid in the provision of spaces. Although, it is a concern that Moulton Primary did have spaces this year in their reception intake, I would assume this to be due to a low birth year as prior to this both Moulton and Overstone have been traditionally oversubscribed. As a parent of a recent school starter, the area does not offer a 2-form school which this will be so will offer an alternative to those already here."
- "More schools are needed."
- "A school is needed in close proximity to the new housing developments."
- "If there is a need for more school places, I support the development of a new school."
- "Great school, fantastic opportunity for the area."

For those stakeholders who answered 'No' to Q1, the following comments were given:

- "As your playground is directly in front of my home and your muggy is directly at the side of
 my home with no direct contact or consultation with the one house that was built before any
 other building work."
- "The road network doesn't support it."


Those stakeholders who answered 'Don't Know' to Q1 have not provided any additional comments.

No clear responses for the category "I don't know".



Q2. Do you understand and support Overstone Park Primary School's proposed Admissions Policy?

Out of the respondents, 77 answered this question and 5 skipped it. 89.61% answered Yes, 5.19% answered No and 5.19% answered Don't Know. The comments support the Admission Policy, but there are still some questions about it from many respondents.



For those stakeholders who answered 'Yes' to Q2, the following comments were given:

- "Caters for the local area"
- "Yes BUT I question whether it should be linked specifically to the Overstone Leys development as there is also the Atrium, the Farmstead, Overstone Gate within a close proximity of the development on which the new school will be located"
- "Not read the admissions policy but would expect it to priorities local people that are on walking distance and would encourage walking as a priority"
- "Starting with Reception only and growing slowly."
- "I do understand it my only query would be that Overstone Leys gets priority over other residents who would actually be closer. For example the Moulton development on The Avenue."

For those stakeholders who answered 'No' to Q2, the following comments were given:

 "The Overstone Leys catchment does not include The Farmstead, which would be closer than some Overstone Leys addresses or Overstone Gate. When buying properties at Overstone Gate and The Farmstead we were told that the Primary School would service this side of the School."




For those stakeholders who answered 'Don't Know' to Q2, the following comments were given:

- "This school is to support growing demand for places at the Overstone Leys development', but those children are 4th in the admissions criteria. How will this work? Also what provisions are in place for much needed SEN children places?"
- "I haven't seen your policy"
- "n/a"

Q3. Do you support Overstone Park Primary School's proposed curriculum?

Out of the respondents, 77 answered this question and 5 skipped. 89.61 % answered Yes, 1.30% answered No and 9.09% answered Don't Know.



For those stakeholders who answered 'Yes' to Q3, the following comments were given, [e.g., please let us know your reason]:

- "It has a proven track record at Wootton Park. It takes in the whole child including who they
 are within the community and wider world. It can therefore support their (inner)
 development."
- "I think it's wonderful how you will have Design and Food facilities."
- "An amazing reflection of Wootton Park"
- "It seems to be a well rounded curriculum, presumably in use at Wootton."
- "It has a proven track record at Wootton Park."



- "Have not seen the curriculum but would expect it to be based on an inclusive policy and also not being fee paying."
- "Based on the outstanding curriculum of sister school, Wootton Park."
- "The proposed curriculum is similar to Wootton Park School."


For those stakeholders who answered 'Don't Know' to Q3, the following comments were given:

"I haven't seen it yet"

Those stakeholders who answered 'No' to Q3 have not provided any additional comments.

Q4. Do you agree that Overstone Park Primary School should open in September 2025, which would involve The Northampton Free School Trust entering into a Funding Agreement with the Secretary of State for Education?

Out of the respondents 78 answered this question and 4 skipped it. 88.4 % answered Yes, 3.85% answered No and 7.69% answered Don't Know.



For those stakeholders who answered 'Yes' to Q4, the following comments were given:

- "Yes, as this is required for the school to progress."
- "School places are needed for yhe children moving into the Overstone Leys new housing."
- "Be a great time to open a parte school to Wootton Park and can support with staff development."
- "More school places asap"



For those stakeholders who answered 'No' to Q4, the following comments were given:

"Wrong choice of location"

For those stakeholders who answered 'Don't Know' to Q4, the following comments were given:

- "The funding route should not be decided by a public consultation. Design needs to fit the teaching needs and long term maintenance rather than potential short term savings on the capital cost as this will lead to higher revenue costs."
- "The main roads, car parking and access needs to be fully in place."

Q5. Do you have any additional comments?

This qualitative section offered respondents the opportunity to express any additional comments. 29 respondents answered and 53 skipped.

7. Open Events and Other Responses to the Consultation

During the consultation period, two Statutory Consultation events were organised:

- Monday 15th of July 2024, from 6:00PM to 7:30PM, a face-to-face meeting at Wootton Park School, Wootton Hall Park, Northampton.
- Wednesday 26th of June 2024, from 6:00PM to 7:30PM, a virtual Teams meeting.

The consultation events provided background information on Northampton Free School Trust (NFST) as well as the trust's proposal to establish Overstone Park Primary School. A Q&A session was held following the presentation, which can be found in (Appendix 2). Both In-person and virtual events were held to give the possibility to everyone to participate in at least one of the consultation events.

In addition to the open events, the trust communicated regularly with stakeholders who emailed questions and comments about the school to the designated consultation email address. See Appendix 9 for a full record of email correspondences regarding the consultation between NFST and local stakeholders.

Virtual Event

During the virtual event on Wednesday 26th of June 2024 for Overstone Park Primary School, the trust introduced the school's ethos and vision, emphasising academic excellence, character development, and community service. They presented plans for a curriculum that includes foundational subjects and specialised courses, all supported by modern, eco-friendly facilities. The school plans to open in September 2025 with one form entry and aims to grow to accommodate 420 pupils, welcoming students aged 4-11. The event concluded with a Q&A session, addressing community questions and concerns. Below are some questions raised and addressed during the virtual Teams meeting.

Q: I am moving to the Overstone area, my new house is just behind the site of the new school. I'm struggling to understand how the traffic flow in the local area will be managed. Will this new build affect the neighbouring houses with busy roads and noise pollution?

A: If we refer back to the building plan, we can see that there will be a footpath that will run the length of the site, connecting to roads and main roads. We have no intention to open access to vehicles. With the new housing developments in the local area and our mission to be environmentally friendly and promote fitness and well-being to children we imagine a significant majority of pupils to live in walking distance. Additionally, we will work with the LA and local area to create and submit a travel plan that all are happy with.



Q: I can see the schools opening with 30 pupils and will be growing to 400 pupils. When will the school reach 400 pupils?

A: Our school will open as a one-form entry with plans to move to a two-form entry. It will open with 30 pupils entering and that will grow to 60 within four years.

In-Person Event

The in-person consultation event was held at Wootton Park School with 8 people in attendance. The event began with NFST CEO Dan Rosser introducing the trust's transition from a single academy to a multi-academy trust (SAT-to-MAT). He then highlighted the school's performance, announced an upcoming tour of the EYFS site and explained the school's two-form entry structure (accommodating 30 pupils each in Y1 and Y2), while also emphasising the importance of partnerships with nearby secondary schools.

Moreover, Dan also addressed some recent developments, noting that planning permission was granted 2 months ago, and that development will proceed once the land is imminently released by developers. Following this, the curriculum key information was outlined. Nat, NFST's Associate VP and EYFS specialist, outlined the core curriculum components, including literacy, numeracy, and science, alongside daily reflection periods and the development of a strong moral compass. The latter will be supported by specialist teachers from Wootton Park School.

Admissions to the school are set to open in September 2024 and will close on January 15, 2025. The school aims to offer a high-quality education, strong community connections, a focus on a family-oriented environment and a SEN team which benchmarks all students to mainstream national performance.

Furthermore, the presentation also touched upon the location and the design of the new school. It will feature an eco-friendly, one-story design with ample green space, an amphitheatre, dedicated outdoor learning areas, and classrooms designed with large windows and direct access to the playground for children in the school. It is important to note that free-flow EYFS classrooms have been installed to encourage interaction, and the shared green space will be available to the community.

Finally, the presentation showed that NFST has opted out of the local authority's coordinated admissions scheme during OPPS's first year, allowing for children to receive two offers – one from NFST for OPPS and one from the local authority, making OPPS a risk-free choice.

The event served as a platform for gathering community feedback. This was very positive overall, with particular interest in admissions and curriculum details. The success of WPS's curriculum and its strong reputation are well-known, and the quality of the school's build, as seen in the flyover video, was also recognised as a strong point. The event also addressed concerns and questions about the opening of Overstone Park Primary School and presented key information about the new school. During the event, questions from attendees were addressed. The following are some of the questions posed and answered ruing the in-person event:

Q: Is there a playing field area?

A: Yes, there is a multi-use games area, and a car park located across the footpath, in addition to a playground.

Q: What does the behaviour policy look like, and how does it fit into the ethos of building the child?

A: The behaviour policy focuses on nurturing children and guiding them on right and wrong as part of the Early Years Foundation Stage (EYFS). Reflective conversations about behaviour are crucial, and the approach is friendly and supportive. The emphasis is on reinforcing positive behaviour rather than focusing on the negative. Behaviour is managed through a traffic-light system, which allows for movement up or down based on actions. Communication with parents is key to addressing concerns early and preventing minor issues from escalating.

Q: Can you clarify the catchment area, especially around Overstone Leys and the Aldi?

A: Initially, the Local Authority (LA) requested a linked map for admissions, which led to a distancebased admissions policy. We are transitioning back to using a linked map. The name 'Overstone Park Primary' is intended to reflect a focus on Overstone Park. The title 'Overstone Leys' was used by the LA during the development of the new housing area, which has since been divided. There is a need to include a map or detailed description of the covered development areas to clarify the catchment area.

Q: What about families living at the Farmstead and Overstone Gate who are unsure of their catchment status?

A: Feedback regarding families at the Farmstead and Overstone Gate who are uncertain about their catchment status will be taken to the LA to request the inclusion of a map or clear descriptors of the catchment areas.

OVERSTONE PARK PRIMARY SCHOOL

Q: What are the admissions criteria?

A: The admissions criteria are as follows: first priority is given to children with an Education, Health and Care Plan (EHCP), followed by Looked After Children (LAC). Next, priority is given to residents living in the linked area, and finally, admissions are based on distance.

Q: Will there be consideration for siblings in the admissions criteria?

A: For the first year, sibling criteria do not apply as there will be no siblings currently attending the school. However, there will be discussions on whether the school will automatically feed into a secondary school and whether this will be a formal part of the admissions process. This decision will be made by the trust and will be subject to further consultation.

Q: Will you offer wraparound care?

A: Yes, we offer wraparound care from 7:30 AM to 6:00 PM every day, including during school holidays. This comprehensive service is managed internally and includes breakfast in the morning and afternoon tea for the children after school. Parents are required to provide 24 hours' notice before using this service. The wraparound care is highly regarded and the WPS summer project is particularly popular.

Q: Will there be two teaching teams for 60 kids?

A: Yes, there will be two teaching teams to accommodate 60 children. The focus will be on phonics and numeracy, with both larger and smaller group work provided as necessary based on ability.

Q: Can my child apply to WPS if they're not accepted at OPPS?

A: Yes, it is worth applying to WPS if your child is not accepted at OPPS. However, keep in mind that distance criteria in the Local Authority admissions policy are likely to be a significant factor in the decision.

Q: Will there be writing books?

A: Yes, writing books will be provided, in addition to resources for phonics.

Q: Can I support the school as a local church member, such as giving assemblies or organising visits to my church?

A: Yes, we are open to community links and would welcome involvement from local church members. Organising visits or giving assemblies would be a great way for the children to learn about religion and engage with the community.



Q: Will you offer pastoral care?

A: Pastoral care will be handled by the wellbeing team rather than being a direct part of the school's services.

Q: Should the Local Authority have made the catchment area bigger due to demand?

A: Yes, there is agreement that the catchment area should be larger due to high demand. However, this decision is outside of our control.

Q: Will there be further engagement events for this school?

A: Yes, further engagement events are planned for the fall term. Details can be found in the marketing strategy and plan folder on the NFST SharePoint.

Q: (Asked by a child) Can I take these toys home?

A: No, but you asked very nicely!

Q: In 5 years, will the number of children entering Year 1 grow to 60?

A: Yes, the school is expected to be two-form entry (2FE) by the third year of opening.



8. Responding to the Findings

This report summarises the findings of the genuine, open and honest consultation exercise undertaken by Northampton Free School Trust.

As outlined by the positive results, the proposed Overstone Park Primary School has considerable support from the local stakeholders. Topics of note from across the consultation are summarised below:

- Generally, there was significantly more positive feedback than negative feedback.
- Overall, many comments expressed strong support for the opening of the new school, emphasising that it will address the growing demand for school places in the area due to ongoing residential development. There is a general agreement that Northampton Free School trust has a proven track record of delivering high-quality education as previously seen by Wootton Park School, which many believe will ensure the new school's success.
- Several respondents also highlighted that the new school is necessary to support the local community, particularly in areas with increasing population due to new housing developments. Therefore, a new local school within walking distance is seen as crucial for the community, reducing the need for long commutes and enhancing local infrastructure.
- The new school is also seen as an opportunity for the local area because it provides high standards of education which is beneficial not only for both pupils and families, but also for the community at large.

However, a few concerns were also raised, particularly regarding the school's name, location, and admissions arrangements. The following concerns, as well as the trust's responses to them, are addressed below:

- A stakeholder pointed out that the proposed school name is very similar to two other nearby schools, which could lead to significant confusion among parents, students and the community.
 - Northampton Free School Trust (NFST) understands that the name may be confusing, however the name of the trust is also attached to the school and the trust considers the relationship between Overstone Park Primary School and NFST to be sufficient to remove confusion regarding the name.
- Several stakeholders expressed concerns about the location of the school, particularly
 regarding its accessibility and whether it serves the correct catchment areas. Thus, some
 residents feel that the chosen site might not be ideal, especially for those living in areas like

The Farmstead and Overstone Gate, who were initially told that the school would adapt to their needs.

In response to this, NFST is committed to ensuring that the school is both accessible and beneficial to the broader community. They also understand that these comments may be due to some confusion regarding the name of the Overstone Leys development, as it was originally designated under one name but was then split into several different names during the planning and development stages of Overstone Park Primary School's construction. It is also important to recognise that these catchment areas have been developed in conjunction with the Local Authority, incorporating demographic planning data for the next 10 years and beyond. For this reason, there will be ongoing reviews of the catchment area boundaries conducted by the Local Authority to ensure they are inclusive and fairly distributed for residents across the local area, including The Farmstead and Overstone Gate. Furthermore, concerns about the location will be addressed in the context of its accessibility and infrastructure. If needed, additional measures such as transportation support can be introduced to make sure that the school effectively meets the needs of all local families.

The trust responses to informational questions asked by stakeholders can be found below:

- One stakeholder asked how the school will be funded, and whether there are guarantees of long-term financial sustainability.
 - The school will be funded primarily with government funding as all free schools are, as well as with support from the trust. Government funding is secured through the Funding Agreement between NFST and the Secretary of State for Education, scheduled to be signed in February 2025. The trust has a successful track record of managing finances effectively, as previously demonstrated through the management of Wootton Park School.
- Stakeholders asked whether the admissions policy will prioritise children from the Overstone
 Leys development, and how it will address concerns about fairness to nearby communities.
 - The admission policy is designed to give priority to children living within the Overstone Leys development, but it will also ensure that nearby communities are also fairly represented. This is in line with the school's commitment to meet the local population's needs. However, it is important to note that the policy will be



under review to make sure it remains fair and transparent as the local population evolves and whether there are any changes over time.

- Stakeholders questioned how the trust will ensure high-quality teaching staff are recruited and retained.
 - The trust has a strong reputation for attracting and retaining high-quality teaching staff, as we can see from Wootton Park School's. Overstone Park Primary School will implement similar strategies, including competitive salaries, professional development opportunities, and a supportive work environment.
- Stakeholders asked whether enrichment activities will be offered and how they will contribute to the pupil's overall development.
 - Overstone Park Primary School will offer a range of enrichment activities designed to complement the academic curriculum and to promote development. These activities will include sports, arts, music and community service opportunities, which are reflecting of the trust's core values on citizenship, community and service.
- A stakeholder asked whether there will be an extended school day, and how this will impact pupils and families.
 - An extended school day is planned to offer additional academic support. This approach has been successful at Wootton Park School and is expected to benefit pupils by providing a structured environment for learning and development beyond school hours. Although this might affect some family routines, the school offers flexibility and support to make sure that the extended day is beneficial and also manageable for all pupils and their families.

The feedback received during the consultation events and the survey has been crucial in addressing any issues and concerns and making sure that the school's plans will meet the community's needs.



9. Conclusion and Recommendations

Responses to the statutory consultation survey demonstrate that a large majority of the respondents were in favour of the proposal to establish a primary school in Overstone Leys. The board of Northampton Free School Trust (NFST) are hugely grateful of the great support given by the community.

Nonetheless, we take seriously all the issues raised and have sought to respond to them. We do not take community support for granted and will not allow ourselves to become complacent in our efforts to ensure that our plans for Overstone Park Primary School reflect the needs and aspirations of our community. We will report regularly on our advancements and progress to ensure local stakeholders are well informed and able to fully contribute to our plans.

We are committed to operating in a transparent and inclusive way, and in keeping with our vision and ethos. We will ensure our recruitment and other policies adhere to the very best practice in equal opportunities and inclusion and will make sure all staff and governor vacancies are widely advertised to the community. We will participate with local networks to develop partnership and collaborate with local community group, charities and private sector companies.

The range of questions asked at the meetings and listed in Appendix 2 highlights the issues discussed and illustrates the willingness of attendees to engage with Trust about their plans.

Subject to DfE approval, this report fulfils Overstone Park Primary School's statutory requirement to consult with stakeholders about its proposal and NFST can proceed with the next phase of the school's pre-opening, with the understanding that no significant barriers or opposition to their proposals have been identified. Based on the responses to the consultation, the Governors agreed they wish to enter into a Funding Agreement with the Secretary of State to open the school from September 2025.

9.1 Recommendations

In response to this consultation, it is recommended that the trust:

- Approve the contents of this report and submit it to the DfE;
- Publish this report on the Overstone Park Primary School website as a record of the consultation and feedback to the participants and wider stakeholders;
- Continue to share updates with stakeholders, through the Overstone Park Primary School website and stakeholder database;
- Continue with its pre-opening work for Overstone Park Primary School with the knowledge that no significant barriers or opposition to their proposals have been identified.
